Highlights from SURS Committees and Board Meeting, September 8-9, 2023

Steven Rock (WIU Representative)

Investment Committee: Two candidates for the Chief Investment Officer position were brought in for interviews before the full Board based on recommendations from the Ad Hoc Search Committee.

For the Defined Benefit (DB) Plan, the annual return for fiscal year 2023 ending June 30 was +5.3%. Due to the severe underfunding of the system (because of past shortfalls in state appropriations), the investment portfolio is set up in a defensive position, which will better protect the system with downside protection but will result in weaker results relative to other better funded pension systems in strong equity markets. This has played out in the last two fiscal years, where SURS underperformed in FY2023 and overperformed in FY2022. Performance over the last three years was +8.8% (36th percentile compared to other funds with assets greater than \$1 billion), +7.0% over the last five years (35th percentile), and +7.5% over the last ten years (42th percentile). The funding ratio is 45%.

Administrative Committee: SURS' auditors, Gabriel Roeder Smith & Company (GRS), reviewed the economic assumptions used in the actuarial valuation that is used to determine the annual state required contribution, based on statute.

Legal and Legislative Committee: The required state appropriation to the system of \$2.12 billion for FY2023 has been paid in full and on time. The required contribution for FY2024 is \$2.13 billion. It is noted that the State has contributed another \$136 million in an extra appropriation over the last

two fiscal years. SURS is following the subject matter legislative hearings on SB4098 and 4099 which deal with potential fixes for Tier II members.

Other: SURS is offering a virtual stakeholder meeting on November 15th. Registration is required. SURS will be holding elections for three active member Board positions and one annuitant Board position. Applications and the ballot signature process will begin in October with the election held in April. More details are on the SURS web site.

Legislative Wins in 2023

The Illinois Alliance for Retired Americans hosted a meeting on June 30 to review 2023 legislative wins. At the meeting, Citizen Action Illinois discussed endorsed legislation. Among many healthcare-related bills were insulin affordability, banning drug price gouging, increasing pesticide exposure penalties, and cultural competence training for healthcare workers. Additional legislation included gun manufacturers accountability, drivers' licenses for immigrants, allowing 16-year-olds to pre-register as voters, fairness and protection of temporary workers' safety, protection for rideshare passengers and a bill that modifies plumbing codes to permit more gender-neutral restrooms. The AFL-CIO reported on a bill requiring charter schools receiving public funding to adopt policies that enforce a neutral position on union organizing. Other bills included protection from harassment for public transportation operators and also for being more accountable for the safety issues of temporary workers. The AFL-CIO is also endorsing changes to casino regulations to allow formerly incarcerated individuals to hold back-of-the-house jobs. Work continues on additional protection for child labor and paid family leave. The state's FY 2024 budget fully funds the pension obligation and includes an additional 200 million dollars to reduce previously underfunded obligations.

Legislative Report

We have some work to do! UPI Retirees can help. The attacks on libraries and schools are escalating. The latest have been bomb threats to libraries. With Illinois no longer allowing "banned books," attention is focusing on keeping collections separated. The attack on schools to limit inclusive information in the curriculum continues. The people who want everyone to only be exposed to their beliefs are across our state and nation. They are preparing for the spring 2024 election. They will be on the ballot as candidates to promote their influence on schools and libraries. You are aware of the issues. NOW is the time for ACTION. Here is where your valuable help can make a difference:

- use any resources you have in your community to find out issues faced by your school and library boards.
- find out who on these boards is a disrupter and who will be on the ballot in April 2024.
- contact friends who know these people, or you can attend their meetings.

This is the first step for taking ACTION to STOP this wave that negatively impacts the rights of all learners to have the opportunity to get information and make choices and decisions!

When you are able to identify the negative forces, you will be able to make decisions about who you will support, how to support different candidates, and how you can effectively become proactive in contacting voters to be sure that our library and school boards work to support learning.

The UPI Retirees Executive Board is very anxious for your help. We truly believe, we can make a difference. We are asking you to "keep us in the loop" and let us know how you are working to make sure we are moving in the right direction. Retiree Executive Board Member Profile - Bruce K Barnard

Bruce K Barnard (EIU Representative)



Bruce K. Barnard retired from the Eastern Illinois University faculty in December of 2020 after 15 years on the faculty of the School of Technology. He served as an Instructor and the Organizational Development Program Coordinator. All his life, he has had strong ties to Eastern Illinois University, where he not only earned a Master's Degree in Technology, but also a Graduate Certificate in Work Performance Improvement, and a Bachelor's Degree in Career and Organizational Studies. During his time at EIU, he was a strong advocate for working adults pursuing undergraduate and graduate degrees.

Before joining the faculty at EIU, Bruce served for more than 30 years in leadership at community-based nonprofits providing addictions treatment, mental health, and community corrections services. While working in community-based programs he developed an interest in non-profit board development, strength-based development, law enforcement and mental health collaboration, and critical thinking self-efficacy. He would carry these interests to his teaching at EIU.

Bruce joined the EIU Chapter of UPI in his first year as full-time faculty. As a member of UPI, Bruce advocated for voluntary representation on department and school committees, and multi-year contracts for non-tenure track faculty. One of his proudest moments at EIU came as the University was struggling to respond to the state budget crisis. Union leadership worked with the administration and the membership voted to defer a contractually obligated salary increase to save the jobs of annually contracted faculty who had received layoff notices due to the uncertainty of the state budget. Bruce was elected to Faculty Senate in 2018.

As a retiree, Bruce continues to work with Sarah Bush Lincoln Healthcare and the Lumpkin College of Business and Technology to maintain a 25-year tradition of leadership development at Sarah Bush through their Leadership Academy. He also keeps a toe in the academic environment by teaching an occasional class or participating in a class that interested him as a student. Bruce and his wife Susan live in rural Piatt County with their horses, cats, and an assortment of wild critters.
